Does it capture all the relevant issues? Are all the issues expressed fully enough? Corrections were received on the detail within the documents which are not listed within these minutes. It was generally felt that the balance of these documents was good, though care needs to be taken to ensure that buried archaeology or non visible archaeology is not downplayed. The issue of Communal value was discussed and the lack of information to be extracted from parish plans etc.

## 6 Focal points in the Landscape – Update

ER provided update on ongoing progress of consultation on local peoples favourite features of historic interest. The Steering Group was presented with the results so far, primarily from the AONB Annual Forum, in the form of an A-Z and the Steering Group debated how this information can be used in the HEAP as a whole. The following points were raised:

- Do these represent the quintessential elements which make the AONB tick? Can we distil out AONB elements into systematic statements?
- Represent a personal list a very small sample
- Need to undertake the exercise at similar events to the AONB Annual Forum in the future
- Could become supplementary to AONB Management Plan
- Could be enlarged in separate booklet

- Threats identified very personal
- Care needs to be taken as these represent the visible and the obvious be careful of perceived features.
- Look at how they contrast with statutory designations how differs from tangible heritage
- Represents personal value could analysis different facets such as childhood, experiential, memory
- Not strictly speaking a focal point do we need a different name
- Provided visual clues through which people can access the past
- Can champion landscape approach
- Must be careful not to give them undue weight but are a valuable aid in building up a picture of the AONB
- Dip into the aesthetic
- Could be used as an educational tool
- Relate well to EH principles
- Look separately at communal focal points
- Create GIS layer for information
